
# TSAB Newsletter

## **Training & Development**

Whilst many face to face training courses have been suspended the Board continue to provide a wide range of remotely accessed, flexible training options in a variety of formats.

#### **E-Learning**



In partnership with the two local Safeguarding Children Partnerships, the Board commissioned Me-learning as its new e-learning provider in May 2020. The first quarter of 2020/21 has seen over 2500 users register on the new system, and there were 2620 Adult course requests.

A wide range of free to access courses are available covering Adults and Children Safeguarding topics, and now includes two new courses:



**Self– Neglect & SARs** : Recognising the signs & symptoms of Self-Neglect **NEW** and hoarding, how to respond and the Safeguarding Adult Review process.

Suicide Prevention: Spotting the signs and how to respond.
