


Summary of the Work of the Board

Mental Capacity Act Guidance—New

The <u>Mental Capacity Act Guidance</u> is a combination of best practice guidance and resources to assist and support practitioners when using the Mental Capacity Act 2005. The guidance provides practical steps to support professionals in following the MCA process. It is not intended to be definitive guidance and should be considered jointly with your own organisation's MCA Policy and Procedures as well as the MCA Code of Practice. Causing Section 42 Enquiries Guidance—Reminder

The <u>Causing Section 42 Enquiries Guidance</u> provides information to professionals who manage or undertake s42 Enquiries. The Local Authority will establish that the criteria for a s42 Enquiry has been met, however it may be that it is more suitable for another organisation to undertake the enquiry. This guidance should be followed by the Local Authority and the organisation identified as best placed to undertake the enquiry.

What is the Team Around the Individual (TATI) Panel?

The Team Around the Individual (TATI) Panel will consider cases in respect of adults aged 18 years or over, where existing mechanisms within agencies for resolving or minimising risk have not been achieved.

The focus of the panel is on addressing the risk to the adult and in doing this will also consider other persons affected, the panel will enable better risk sharing and risk management between agencies and facilitate better outcomes for people. The panel will support agencies in their work to lower and manage risk.

Aims:

- ✓ To share information to identify, clarify and agree on risk
- ✓ Promote safety and wellbeing of high risk adults
- ✓ Improve multi-agency communication pathways
- ✓ To improve agency accountability
- ✓ For those who are not engaging, co-ordinate a risk management plan to seize the opportunities that can enable engagement and/or monitor the well-being of the person.
- ✓ To utilise resources more efficiently and to develop risk management plans
- ✓ To share risk across agencies and identify of a lead/key worker

A Case Study of a TATI Panel is provided below:

An individual in their 60's who had a history of self-neglect was referred into the Local Authority safeguarding team and subsequently referred into the Team around the Individual (TATI) panel. The individual lived alone in a rented property, had a long history of alcohol dependency and there were concerns regarding home conditions. Work was carried out within the property to improve living conditions and further work was planned, however it was unfortunately halted by COVID. The individual had a history of non-engagement with professionals due to past experience and although willing to speak via phone refused to allow professionals into their home.

It is usual practice for all agencies to share information about historic and current involvement during the TATI meetings and at the point of the referral to TATI there were concerns that the individual faced risk of eviction due to the current living conditions.

The case was heard at TATI on a monthly basis for 6 months, case progress was hindered significantly by the impact of COVID as visits were halted during this period.

Progress was noted after 3 months by agencies in terms of engagement on the telephone and a reported reduction in alcohol intake. After 5 months there was further progress noted by other agencies in building relationships and agreements made to ensure safe living conditions. This led to the closure of the case to TATI. Nine months later the individual continues to receive support from agencies including Adult Social Care. Support packages are in place, and the individual is now engaging with professionals, has reduced their alcohol intake and is no longer at risk of eviction. The individual now has involvement with their family which was not previously the case.


New E-Learning Courses available

TSAB are always reviewing our training offer and are pleased to launch three new courses:



Loneliness and Isolation

Loneliness and isolation is a growing issue, and it doesn't just affect older people. This Loneliness and Isolation course is for anyone who comes into contact with people who might be lonely or isolated. It will provide an awareness of what isolation and loneliness is, who might be vulnerable, how to spot signs that someone might need help and what you can do to help tackle this issue.



Dementia Awareness

This course provides an introduction to dementia, including the causes of dementia, treatments for dementia, symptoms and progression of dementia, and working with people with dementia. The course discusses the effects on the person with dementia, and how those effects can be addressed through the use of communication techniques, adjustments to the physical environment, and an understanding of the problems faced by people with dementia.



Substance Misuse

This Substance Misuse course will enable you to understand how drugs work, how their use affects people and their families and how addicts can be helped to recover.
